## Hyundai Flyers 2016-2017 Road Trip Sweepstakes December 18, 2015 – April 8, 2016

## Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN. VOID OUTSIDE PA, NJ AND DE AND WHERE PROHIBITED.

- 1. LIMIT ONE ENTRY, PER PERSON, PER DAY, REGARDLESS OF METHOD OF ENTRY. For the purposes of these Official Rules, a "day" will start at 12:00:00 a.m. ET and end at 11:59:59 p.m. ET (except for the first day which will commence upon the posting of the Official Rules). Spectrum Arena Limited Partnership's computer shall be the official timekeeper for all matters related to this Sweepstakes. If an entrant uses the same, different or multiple email addresses to obtain more than one (1) entry per day, all such entries will be void. Entries generated by script, macro or other automated means and entries generated by any other means which subvert the entry process will be void. Entrants must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete and/or inaccurate entries are void.
